## 2. New features

### 2.1. “2A from scratch” : 2 new fields added to achieve case management

2 new fields are added to the 2A script in order to be transmitted to Regions for case management:

- National registration number of index patient (index\_patient\_ssin)
- Cluster ID (cluster\_id)

## 2.2. Script 1A: flag whereabouts for case management

A series of changes have been made in the “event” section of script 1A to determine whether a “whereabout” should be marked as a “case management” and transmit the information in JSON exports to regions.

### 2.2.1. New flag in export to Regions

### 2.2.2. Event type update

- New type of private event : « Une activité avec un mouvement de jeunesse »
- all types of public events have been split up individually

### 2.2.3. Trigger for case management

If the agent adds a private event (all type) or for certain public events (with the following type “conference, trade fair, event, restaurant, café, fitness, sauna, wellness center, bed&breakfast, other), 2 new questions are added at the end of the form:

- Among the following events, which are the ones where you CANNOT list all the contacts present?
  - “Name of added event 1” → *if selected = flag this event as “CASE MANAGEMENT” and hide this event in question 2*
  - “Name of added event 2”
- For which of the following events is the index patient aware of the presence of other infected individuals?
  - Name of added event 2” → *if selected = flag this event as “CASE MANAGEMENT”*

## 2.3. Other changes

In the popup for creating/adding a new event:

- **Field “Name/description”** is split into 2 distinct fields
- **Fields “Name of event”, “Description of event”, “Post Code”** are now mandatory
- Addition of the **address autocomplete library**

## 2.4. 1B ticket via eHealth Box version 1.2

Evolution of the functionality for sending 1B tickets via eHealth box / email:

- **“List of symptoms”** selected in 1A ticket is now included in the file attached to eHealth box and in the generated content for email
- **“Symptom start date”** selected in 1A ticket is now included in the file attached to eHealth box and in the generated content for email
- The operator can add **a comment** which will be included in the file attached to eHealth box and in the generated content for email
- **The contact email address** in the introduction of the message will be displayed according to the region
