### 2. New features

# 2.1. New wrap-up codes for the resending of CTPC codes and Quarantine certificate

It is now possible to resend the CTPC/PCR codes and the quarantine certificate on request of the citizen via the scripts.

#### In order to resend CTPC/PCR codes

- Agent will select the wrap-up inbound/success/ "Resend PCR code" in script 2C, 2E,2D,2A
- By default, the telephone number initially entered in the script will be used.
- The citizen can enter a new phone number in a field that will be displayed below the wrap up codes
- SMS will be send on form submit


#### In order to resend Quarantine Certificate

- Agent will select the wrap-up inbound/success/ "Resend Quarantine certificate" in scripts 2C, 2E,2D,2A
- By default, the email address initially entered in S&F will be used.
- Citizen can update his/her email address in a new field displayed below the wrap up codes in script 2E, new wrap-up code will also be available for outbound calls, because for this script PCR Code and Quarantine are sent before 2E scheduled.

#### In order to resend CTPC/PCR codes and Quarantine Certificate

- Creation of a new wrap-up code inbound / success / "Resend PCR and Quarantine Certificate" in script 2C, 2E,2D,2A
- By default, the email address and phone number initially entered in S&F will be used.
- Citizen can update his/her phone number and email address in 2 new fields displayed below the wrap-up codes
- in script 2E, new wrap-up code will also be available for outbound calls, because for this script PCR Code and Quarantine are sent before 2E scheduled.





### 2.2. Various script updates

#### 2.3. Script 1B - New index patient data

Index patient's Region and Zip Code is now displayed in "Patient index information" area.

#### 2.4. Script 3B - Traveller label

The label "traveller: yes / no" is now displayed at the top of script 3B to indicate that the citizen comes from the "Passenger Locator Form" flow

#### 2.5. Script 2B, 3B, 1B - New symptoms

Addition of 3 new minor symptoms to align all scripts with the 27 may release (nausea, vomiting, tiredness)

#### 2.6. Script 1A - Label « treated directly »

In the summary of the added contact, next to the first name, name of the contact and the place of meeting with the index patient, a new column with the mention "treated directly: yes no" for House members treated directly in the call has been added



#### 2.7. Script 2A, 2C and 2A House Members - Removal of Q5

Q5 "Dans le cadre de votre travail, vous occupez-vous de personnes âgées, de personnes souffrant d'une maladie chronique telle que le diabète ou une maladie cardiaque ou pulmonaire, ou de personnes ayant un système immunitaire affaibli ou une maladie cancéreuse active ?
