Version and guidelines in use as of 21/06/2021

Context

In the meantime, the travel ban has been lifted and it is expected that **travel will increase significantly in the coming weeks**.

Labs, triage centers, doctors and other parties involved already experience that the testing of departing travelers brings with it an extra workload in terms of testing, registration, follow-up payments and inquiries / accessibility of the result (impatient travelers). It is therefore very important that all links are well aligned with each other. This also includes integration of the result via the Sciensano database (DB) and the app CovidSafeBE (app for European Digital COVID Certificates (DCC)).

Every **Belgian resident** who has not yet had the opportunity to be vaccinated will receive 2 **free test tickets** (2 times reimbursed sample taking and analysis for sampling as of July 1st until (and including) September 30th).

The guidelines for certain fields in the LaboratoryTestRequest (V4) have been adapted in order to ensure data completeness throughout the flow, see table.
