## 2. Update 27-11-2020

Impact on **LaboratoryTestRequest** (to support new “*LaboratoryTestRequest*” message specification) :

- New field “*sampleTypeConceptCode*” => SNOMED code from sciensano

- Existing field “*sampleType*” become optional and is deprecated in favour of “*sampleTypeConceptCode*”. Should not be used anymore.
- New field “*testConceptCode*” => LOINC code from sciensano

- Existing field “*testType*” become optional and is deprecated in favour of “*testConceptCode*”. Should not be used anymore.

## 3. New features

### 3.1. Prescription

#### 3.1.1. Indicate if my patient is an essential worker when creating a prescription

Documentation updated on field “*healthCareWorker*” : indicates if the patient is working in health care sector or an essential sector.

### 3.1.2. User can suggest a test type while creating a prescription

New optional field *suggestedTestType*, allowed values are [ANTIBODY, ANTIGEN, PCR, ANTIGEN\_OR\_PCR]

## 3.2. New resource for « sampling »

### 3.2.1. Submit sampling

New operation to record a sampling (related to CTPC code). See “*saveSamplingRequest*” in swagger documentation

### 3.2.2. Get sampling

New operation to get a sampling (related to CTPC code). See “*getSamplingRequest*” in swagger documentation

## 3.3. New resource for “test execution”

### 3.3.1. Submit a test execution

New operation to submit a test result (related to CTPC code). See “*saveTestExecutionRequest*” in swagger documentation

**Attention :** the test result (resultCode) won't be stored in CTPC Data Base

### 3.3.2. Get a test execution

New operation to get a test result (related to CTPC code). See “*getTestExecutionRequest*” in swagger documentation

## 3.4. Consultation of CTPC Code

- Except for the reason “High Risk Contact”
- From now on, **the default validity period** of a CTPC code is set as "contact date plus 14 days"

## 4. Improvement

- For prescription, allow PATCH ssin if the new value is the same as the old one
  - Previously it raised a 409 Error
